Court of Federal Claims, and the FAA's Office of Dispute Resolution for Acquisition. We have also filed protests on small business issues and pursued appeals before the Small Business Administration's Office of Hearings and Appeals.

Our attorneys have litigated Government Contract claims at the U.S. Court of Federal Claims, the Armed Services Board of Contract Appeals, and the new Civilian Board of Contract Appeals, as well as the predecessor boards of contract appeals such as the General Services Board of Contract Appeals, the Energy Board of Contract Appeals, and the USDA Board of Contract Appeals, among others.

Trademarks

A trademark is a word, phrase, or symbol that is distinctive of goods or services and is used in a manner that identifies those goods or services and distinguishes them from the goods or services of others. Trademark registration is often beneficial for businesses.

Copyrights

Copyright law protects original works of expression. A copyright prevents another from copying literary works; musical works; dramatic works; choreographic works; pictorial, graphic, and sculptural works; motion pictures and other audiovisual works; sound recordings; and other similar devices.

Trade Secrets

Trade secrets protect innovations that are secret and bestow a commercial advantage to the keeper. It is often advantageous to use trade secret protection rather than patent protection for certain types of inventions. The trade secret protection is very different from the patent protection.

What is Probate? The legal process of transferring property upon a person's death is known as "probate." People generally formalize their intentions regarding the transfer of their property in a will. During probate, the decedent's estate and property is subject to an accounting, certain debts are paid from the estate, and the property is distributed.

- Collecting all probate property of the decedent;
- Paying all debts, claims and taxes owed by the estate;
- Collecting all rights to income, dividends, etc.;
